

COLD LAKE DETACHMENT ANNUAL REPORT (MUNICIPAL/PROVINCIAL 2022)

Cold Lake detachment's Municipal calls for service for 2022 were 7558, this was a 12.4% increase compared to last year. Cold Lake detachment's Provincial calls for service for 2022 were 3852, this was a 4.3% decrease compared to last year. Total calls for service was 11,410 compared to 10,748 in 2021. Calls for service includes calls from the public as well as self-generated and proactive files. The total 2022 prisoner count for Cold Lake detachment was 1092 compared to 1076 in 2021.

As the Detachment Commander, I am comfortable with the direction and progress of the detachment and the established objectives and priorities, which includes traffic safety, employee wellness, crime reduction and community engagement. Drugs and crime reduction will continue to be detachment priorities.

The annual Mayor's report is compiled by an RCMP Analyst, based on his reports, Mischief and Mental health calls are the top two call for service for the Cold Lake detachment.

The detachment will continue to work with the media, and other partners such as the Crime Reduction Unit, and St. Paul Traffic Services, in an attempt to educate the public on traffic safety and ways to protect themselves from persons and property crimes.

Cold Lake detachment (Municipal) saw a 15% increase in Criminal Code offences, with the increase being in property crime, persons crime and other Criminal Code offences.

Cold Lake detachment (Provincial) saw a 4% decrease in Criminal Code offences, with decreases in property crime and other Criminal Code offences.

Criminal Code per Regular Member (CC/RM):

Criminal code incidents per Regular Member refers to the proportion of criminal code incidents to the number of police officers.

Crime Severity Index (CSI):

The Crime Severity Index tracks changes in the severity of police-reported crime by accounting for both the amount of crime reported by police in a given jurisdiction and the relative seriousness of these crimes. It tells us not only how much crime is coming to the attention of police, but also about the seriousness of that crime.

By design, the specific Crime Severity Index value in a given jurisdiction depends on its mix of crimes and their relative seriousness. If a jurisdiction has a high proportion of less serious, and hence lower-weighted, offences, it will have a lower Index value. Conversely, a jurisdiction with a high proportion of more serious crimes will have a higher Index value. The base line for measurement of the CSI is 100.

Detachments with a population less 5,000 should compare CSI rates with caution. A few serious files could cause large increases the overall CSI. The 2021 CSI will be published in July or August, 2022.

Criminal Code Cases per 1,000 (CC/1000):

The traditional crime rate is expressed as a rate per 1,000 population. The crime rate is calculated by summing all Criminal Code incidents and dividing by the population.

Police to Population Ratio (PPR):

The police to population ratio (PPR) quantifies the relationship between the number of police officers and the total population served.

The Cold Lake detachment will continue to remain focused on property crime and prolific offenders identified in our communities and surrounding area. We will continue to monitor all prolific offenders identified, to ensure that they are strictly abiding by the conditions of their court orders. If the offenders do not change their criminal behavior, enforcement action will be taken. The detachment will implement crime reduction strategies in high risk areas and continue to work with the district and Lakeland Crime Reduction Units targeting high risk prolific offenders in the area in order to increase public safety and reduce property crimes.

The 3-member Lakeland Crime Reduction Unit has been very busy this year and have made 133 arrests, laid 315 charges, executed 70 arrest warrants, recovered approximately 2.8 million dollars in vehicles and other stolen property, and written and executed 8 search warrants.

Drug activity in the community and surrounding area will continue to be a detachment priority as we continue to see methamphetamine, cocaine and opioids in the community and area. The detachment will continue its efforts in information gathering, monitoring and enforcement on drug trafficking, targeting drug traffickers in the community and detachment area.

The Cold Lake detachment will continue to conduct preventive and proactive patrols during high crime times to ensure we maintain a strong presence, ensuring community concerns and issues are being addressed and unit priorities are being met.

The Cold Lake RCMP for the majority of the year experienced a full complement of detachment resources for 2022. Cold Lake has 19 municipal positions, with 17 officers working, there is 1 hard vacancy and 1 officer off duty sick. Cold Lake also has 14 provincial positions, with 13 officers working and 1 on parental leave. 2 members (Cpl's) have been promoted out of the detachment and are currently waiting to sell their residence before transfer. These 2 Cpl positions are currently being advertised for promotion. 1 Cst is transferring out and is currently awaiting to sell their residence. 1 Cst in a bilingual position has been transferred in October and a replacement has yet to be identified resulting in the hard vacancy.

I hope this brief overview and attachments of the 2022 statistics for Cold Lake detachment, both Municipal and Provincial, meets your approval as we continue to move forward with the identified 2023 priorities.

Criminal Code Offences

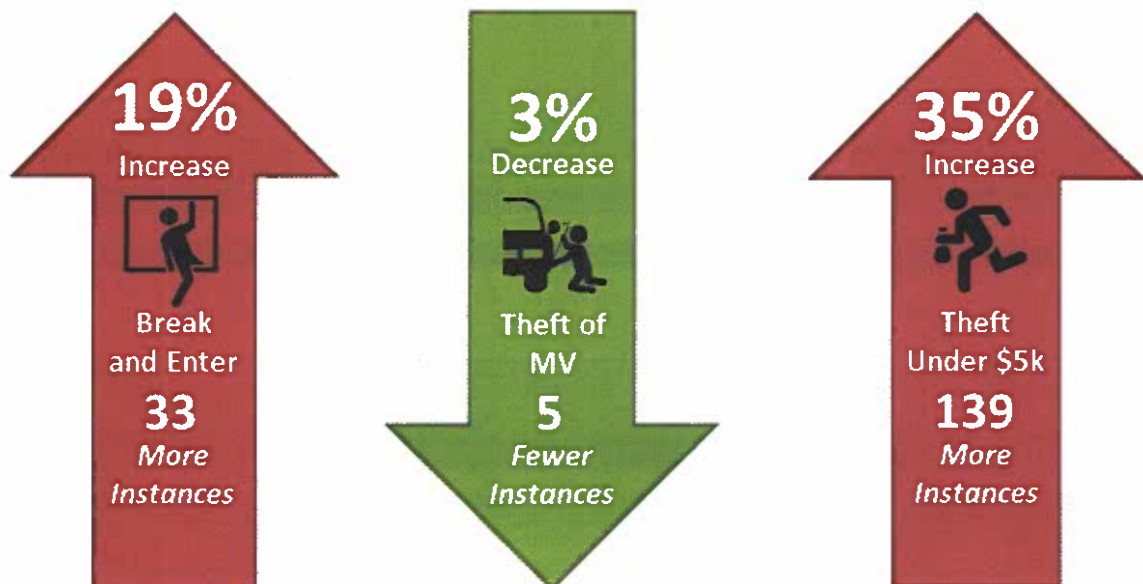

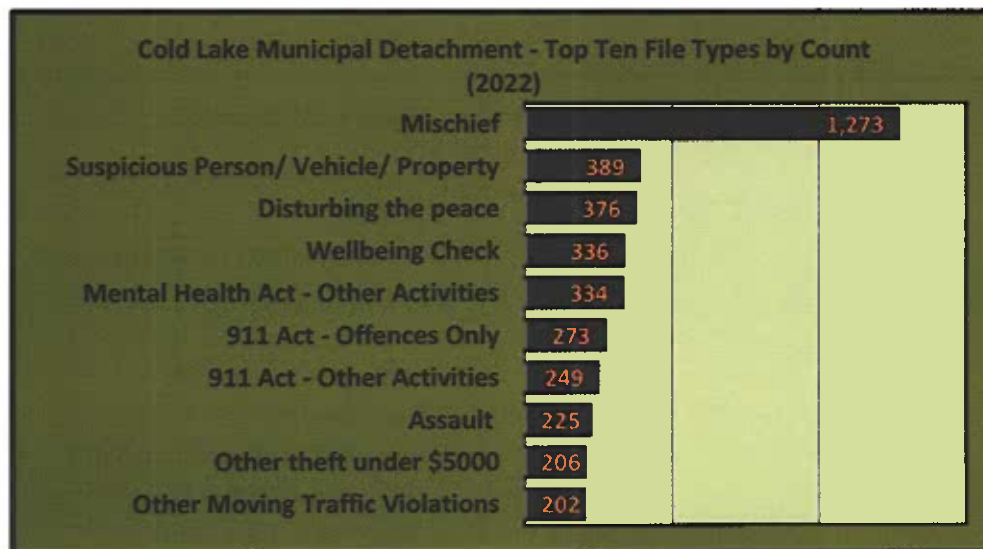

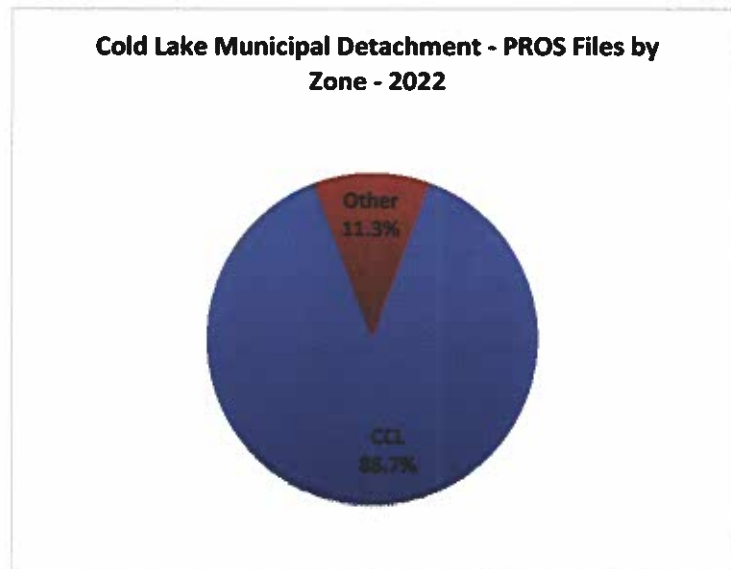

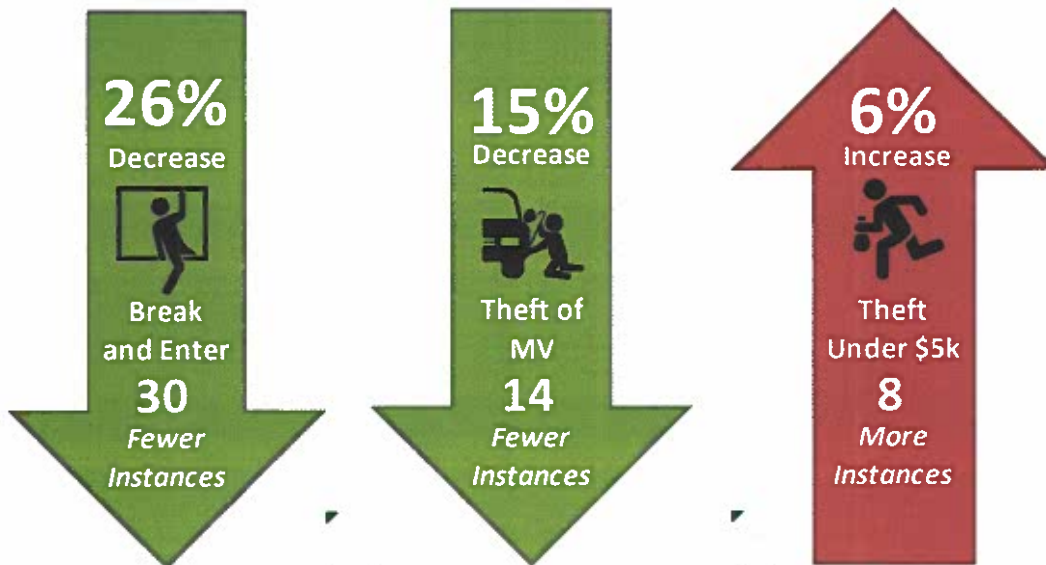

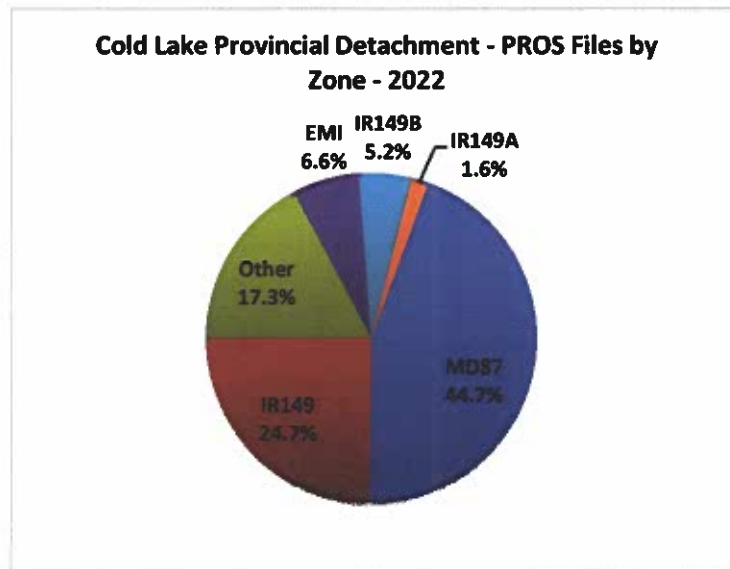
